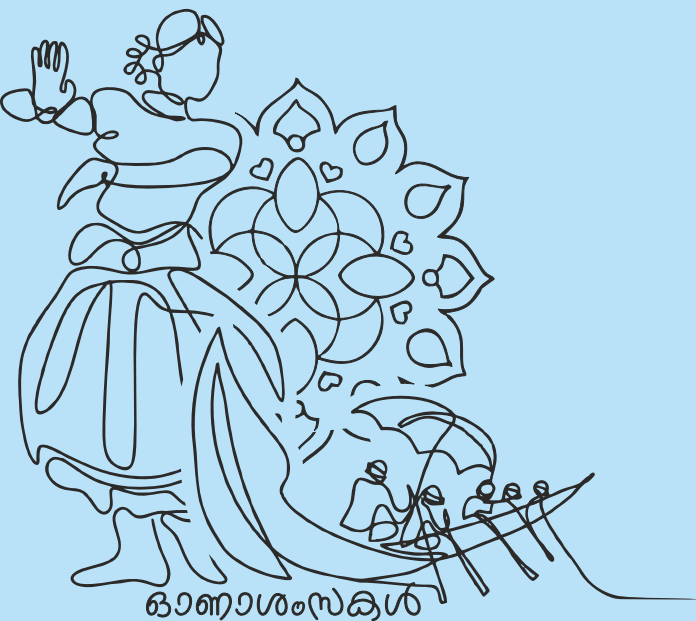

**Opinion**

We have audited the financial statements of **Kerala Travel Mart Society** which comprise the balance sheet as at March 31, 2022, and the statement of Income & Expenditure for the year then ended, and notes to the financial statements, including a summary of significant accounting policies.

**Basis for Opinion**

We conducted our audit in accordance with Standards on Auditing (SAs). Our responsibilities under those Standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are independent of the entity in accordance with the ethical requirements that are relevant to our audit of the financial statements, and we have fulfilled our other responsibilities in accordance with these requirements. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

**Responsibilities of Management and Those Charged with Governance for the Financial Statements**

Management is responsible for the preparation of the financial statements and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is responsible for assessing the entity's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the entity or to cease operations, or has no realistic alternative but to do so. **Schedule No. 10 – Significant Accounting Policies and Notes on Accounts**

**A. Significant Accounting Policies**

**1. Basis of Accounting**

The accounts are prepared under the historical cost convention on accrual basis of accounting.

**2. Use of Estimates**

The preparation of the financial statements in conformity with Indian GAAP requires the Management to make estimates and assumptions considered in the reported amounts of assets and liabilities (including contingent liabilities) and the reported income and expenses during the year. The Management believes that the estimates used in preparation of the financial statements are prudent and reasonable. Future results could differ due to these estimates and the differences between the actual results and the estimates are recognised in the periods in which the results are known / materialise.

**3. Fixed Assets**

Fixed Assets are stated at cost less accumulated depreciation.

**4. Depreciation**

Depreciation is provided as per the method prescribed under Income tax act, 1961 and at the rates given below.

Particulars	Rate of Depreciation
EDP Equipment	40%
Furniture and fixtures	10%
Office equipment, Telephonic Installation and Electrical Installation	15%
Computer Software	40%

**5. Revenue Recognition**

Membership entrance fee is considered as capital receipt and credited to Capital Fund. Annual Subscription fee is considered as revenue receipt and credited to Income and Expenditure Account. Revenue from Kerala Travel Mart is recognized upon rendering of the service. Interest income is recognised on time proportion basis.



**B. Notes on Accounts**
